# CYE 2022 DAP Final Public Notice

- Posted the [Final Public Notice](#) on April 5.
- Changes from the Preliminary Public Notice:
  - Updated the HCBS DAP timelines to allow providers more time to qualify.
  - Added a Closed Loop Referral System (CLRS) DAP for Behavioral Health Outpatient Clinics, Integrated Clinics, Physicians, NPs, PAs, and Other Behavioral Health Providers (1.0%).
  - Added an ASAM Software Integration DAP for BHOP Clinics, Integrated Clinics, Physicians, NPs, and PAs (0.5%).

# Attribution/Assignment Modeling Guidelines

- AHCCCS reviewed feedback from the MCOs regarding the preliminary guidelines.
- AHCCCS is finalizing the updated guidelines and plans to send them to the MCOs for feedback by the end of next week.
- AHCCCS will host a MCO workgroup meeting in May for discussion on the revised guidelines, which will become effective October 1, 2021.

# Stakeholder Engagement for CYE 22/CYE 23 VBP Initiatives

- AHCCCS is in the process of finalizing a VBP Request For Information (RFI) which will be posted to the AHCCCS website in early May.
- The RFI will allow AHCCCS to solicit feedback from MCOs and other stakeholders regarding its VBP initiatives for CYE 22 and CYE 23.
