

## **AHCCCS 270/271 Changes Archive**

To: AHCCCS 270/271 Trading Partners  
Subject: Upcoming 270/271 Changes

Since the implementation of Version 5010 of the AHCCCS Batch 270/271 Eligibility Verification Request and Responses and AHCCCS Online Eligibility Verification, Trading Partners have found the process to be too restrictive. This resulted with a Trading Partner's inability to reconcile eligibility data within their business processes.

AHCCCS recognizes the importance of this and has agreed to allow some modifications to the 270/271 and AHCCCS online applications to accommodate these needs.

The following system changes will be made to the AHCCCS Batch 270/271 Eligibility Verification Request and Responses and AHCCCS Online Eligibility Verification response:

- Add a new search option of SSN/DOB/Last name
- Allow for an unlimited DOS search for hospitals (AHCCCS provider type 02)
- For all other providers, change the Date of Service restriction from 24 months to 36 months

### Testing Timeline:

The system changes will be made available in the AHCCCS Test region beginning 4/1/14. Existing AHCCCS 270/271 Trading Partners who are interested in submitting Batch 270 Eligibility Request files to the AHCCCS Test region may do so by following the normal Testing procedures. Batch 270 Request files should be submitted to the "TEST/EDI-IN" directory on the SFTP server.

### Production timeline:

The system changes will be made available in the AHCCCS Production region beginning on 4/10/14. This applies to the AHCCCS Batch 270/271 Eligibility Verification Request and Response as well as the AHCCCS Online Web Verification system (<https://azweb.statemedicaid.us>).

Hello AHCCCS Trading Partners! You are receiving this broadcast because you either previously identified yourself as the EDI contact person for your organization or you may have contacted AHCCCS regarding an EDI issue. If you are no longer the EDI contact person for your organization or to initiate questions pertaining to this broadcast, please contact EDI Customer Support via the email below. In addition, please forward this information to others within your organization on a need to know basis.

Effective April 22, 2009, AHCCCS is making a change to validate 270/271 files. The structure of the 270/271 will not change, just the external file name. Validating the 270/271 files will help to ensure that the Trading Partner is transmitting an EDI compliant 270 file to AHCCCS and also to help ensure that AHCCCS is transmitting an EDI compliant 271 file to the Trading Partner.

270 requests that pass the front-end validator edits will be sent to the mainframe for processing and those that do not pass the front-end validator edits will be identified in an 824 file. When this occurs, please expect to find that your submitted 270 file may be split between good and bad records. Refer to the Trace Number found in the 2000C/TRN02 data element when tracing 270 requests. Additionally, a more informative 824 file will be produced to identify erred segments. Please refer to the 824 sample file found at the end of this document.

To assist trading partners in submitting compliant X12 files, we are providing a new validation tool referred to as Community Manager. Community Manager is a web portal that allows trading partners to validate files prior to submitting them to AHCCCS. You will receive a separate email regarding your Community Manager account with further instructions.

#### **File naming convention changes for the 271, 824, 997, and TA1 files:**

271: XXD271-pppppp-yymmdd-nnnnnnnnn.TXT

Additionally, AHCCCS will be requesting that Trading Partners include any of the following minimum data sets within a 270 request to perform a member search:

- AHCCCS ID + Member name
- AHCCCS ID + DOB
- AHCCCS ID + SSN
- Member name + DOB
- Member name + SSN
- DOB + SSN
