Subject: AHCCCS Implementation of APR-DRG Methodology Effective October 1, 2014

## Dear AHCCCS Stakeholder:

In 1993, AHCCCS began reimbursing hospital inpatient claims using a tiered per diem methodology and fee schedule as required by Arizona law. AHCCCS hospital rates were rebased in 1998 and, since that time, the fee schedule has been inflated annually (except as otherwise authorized) by using a nationally recognized hospital market basket inflation factor such as DRI.

To further AHCCCS' goals of enhancing quality of member care and promoting efficient delivery of services, in October 2014 AHCCCS intends to transition from the twenty year old tiered per diem inpatient reimbursement system to an APR-DRG payment system. Payments under the APR-DRG methodology will be consistent with efficiency, economy, and quality of care. Our extensive research indicates that an APR-DRG payment system will offer many opportunities to improve member safety and health outcomes as well as improve program efficiency–in contrast to the tiered per diem methodology will underscore the Agency's multiple quality of care initiatives as well as its emphasis on improving patient care. Moreover, the APR-DRG payment methodology will enhance AHCCCS' ability to implement performance review and cost-saving measures.

AHCCCS has contracted with Navigant Consulting to provide assistance in analyzing the impact of acquiring and implementing the new payment system.

There are a number of ways you can stay informed about this project:
