- 2) The capitation rate ranges are equivalent to the bottom half of the actuarially sound rate ranges, from an adjusted minimum to the midpoint. The minimum of each published range was increased by 1% to account for the Payment Reform capitation withhold of at least 1%. The 1% was added to ensure that, after capitation rates are reduced by the 1% withhold, those rates remain within the actuarially sound rate ranges. All bids must fall within the ranges provided above or be scored zero points.
