6. PURPOSE: To retroactively amend select Capitation Rates for the month of September, 2013.																					
<p>7. THE CONTRACT REFERENCED ABOVE IS AMENDED AS FOLLOWS</p> <p>Section 9010 of the Patient Protection and Affordable Care Act (ACA) requires that the Contractor pay a Health Insurer Assessment Fee (HIF) annually based on its respective market share of premium revenues from the preceding year (calendar year 2013 revenue). AHCCCS provides funding to the Contractor for the Health Insurer Assessment Fee and associated taxes subject to receipt and review of documentation from the Contractor as required by AHCCCS.
