Fee-For-Service Health Plans

AHCCCS was implemented on October 1st of 1982 as the nation's very first statewide health care program aimed at providing medical care for individuals undergoing financial hardship. The Division of Fee-For-Service Management (DFSM) is a division within the Arizona Health Care Cost Containment System (AHCCCS). DFSM serves as the health plan for Fee-for-Service (FFS) Medicaid members and reimburses claims for other populations of individuals not enrolled with a contractor.

AHCCCS Online Provider Portal

The AHCCCS Online Provider Portal can be used to submit and status claims and prior authorizations for the FFS plan in addition to verifying member and provider information.

- To register for an online account: https://ao.azahcccs.gov/Account/Login.aspx
- On the left-hand side of this page under the heading NEW ACCOUNT, click "Register for an AHCCCS Online Account".
- Providers who have a valid NPI number must enter the NPI and the Tax ID number.
- Providers who only have a six-digit AHCCCS Provider ID number must use the 6digit ID and their Tax ID number.
- Follow the prompts and complete the required fields. A confirmation letter with
 the authentication access code will be sent to you by regular mail (to the
 provider's correspondence address that is on file with AHCCCS) within 10 business
 days. The authentication access code will not be faxed or emailed to a provider.

Transaction Insight Portal (TIBCO)

The Transaction Insight Portal is a free application for FFS Providers to use to submit required documentation for review. Providers must have a user account to access TIBCO.

How to Sign Up for the Transaction Insight Portal:

Providers can send an email to servicedesk@azahcccs.gov requesting the service ticket to be assigned to ISD Data Security. When you request an account set up, please include the following information:

- Name of your organization, Provider Identification Number, Your full name, and
- Business email address.



Fee-For-Service and IHS/638 Provider Billing Manuals



AHCCCS Fee-For-Service Provider Billing Manual

The <u>Fee-For-Service Provider Billing Manual</u> provides general guidance and billing information for registered providers who are rendering and billing AHCCCS FFS for covered services.

The FFS manual is a practical guide to assist AHCCCS providers in receiving reimbursement. Providers are expected to periodically review the manual to ensure accurate claims processing and reimbursement, AHCCCS policies and procedures. The manual can be used by providers who submit electronic and paper claim submissions on the CMS 1500 (837P), UB-04 (837I) and ADA (837D) claim forms.

AHCCCS Medical Policy Manual (AMPM)

The <u>AHCCCS Medical Policy Manual (AMPM)</u> provides information for both Contractors (AHCCCS Complete Care (ACC) plans and for FFS Providers regarding services that are covered within AHCCCS programs.

The AMPM is applicable to *both* Managed Care Organizations and Fee-For-Service (including IHS/638) providers.

The AMPM should be referenced in conjunction with State and Federal regulations, other agency manuals such as the AHCCCS Contractor's Operations Manual (ACOM), the Fee-For-Service Provider Billing Manual, the IHS/Tribal Provider Billing Manual, Claims Clues, and applicable contracts (MCO's enter into contractual arrangements with providers).

The AHCCCS Medical Coding Unit is responsible for the update and maintenance of all medical coding related to AHCCCS claims and encounters processing. This includes place of service, modifiers, new procedure codes, new diagnoses, and coding rules. This unit is also responsible for reviewing and responding to any medical coding related guidelines or questions. This includes questions related to daily limits, procedure coverage, etc.

The information offered on this web page will include but not limited to Behavioral Health Services Matrix, COVID-19 medical billing information, Coding Related Exhibits, Reference Table Review and Update Requests, Dental Coding, FAQs, etc.
