As previously communicated:

- AHCCCS will manage exchange of encounter and claims data to Contractors in order to eliminate “blind spots” for services provided to a member shared by multiple programs for shared enrollment timeframes; data will be provided in compliance with Federal privacy regulations; contractors should use this information to develop short- and long-term strategies to improve care coordination; ongoing – provide at least quarterly based upon encounters adjudicated in the quarter.
