- 6,819 Prop 204 Restoration (0 - 100% FPL)
- 3,937 Transitional Medical Assistance (TMA)
- 1,708 Adult Expansion (100% - 133% FPL)
- 1,252 1931 AHCCCS for Families & Children
- 954 SOBRA Child
