From January 1, 2024, to February 1, 2025, the population decreased by 13,279 members, or less than 1%.

There were no major increases in the AHCCCS population from January 1, 2024, to February 1, 2025.

- 4,597 1931 AHCCCS for Families & Children
- 3.783 SOBRA Child
- 2,906 Transitional Medical Assistance (TMA)
- 2,617 Prop 204 Restoration (0 100% FPL)
