Did calculations used in the analysis factor in the 85% crisis encounter expectation that supports ensuing available capacity to always say yes to referrals for care in the crisis system?	For Central, AHCCCS revised the Crisis Funding table to exclude amounts for services that are not part of the RFI. The new figures presented in this Crisis Funding table include only crisis services being discussed in the RFI. The revised Crisis Funding data shows a slight decrease in CYE 2019 for the Central GSA. The Crisis amounts in the CYE 2019 rates were the projected amounts for the crisis services being discussed in the RFI as provided by the RBHAs.
