Updates to Arizona's Plan for the CMS Home and Community Based Services (HCBS Rules)

Purpose

AHCCCS is hosting forums to obtain public input on updates to the State Transition Plan after preliminary approval has been granted by the Centers for Medicare and Medicaid Services (CMS). The purpose of the HCBS rules is to ensure individuals receiving HCBS are integrated into their communities and have full access to the benefits of community living. These requirements impact individuals in the Arizona Long Term Care System (ALTCS) receiving services in residential and non-residential settings such as assisted living facilities, group homes, adult day health, day treatment and training, center-based employment programs, etc. AHCCCS will review the updates to the State Transition Plan which outlines the standards for all settings to come into compliance by March 2022. The State Transition Plan will be available on the AHCCCS website (www.azahcccs.gov/HCBS) for a 45-day public comment period.
