Dear Governor Ducey:

Pursuant to A.R.S. 36-3405(D), AHCCCS is required to provide a monthly report that shall, by Regional Behavioral Health Authority (RBHA), separately report Title XIX and Non-title XIX categories and shall include for each category the number of persons served, the units of service and the amount of funding provided for client services and the amount provided for RBHA administration and case management expenses.

To fully support the State's efforts to stem the spread of the novel Coronavirus (COVID-19), and serve Arizonans who've been affected by the national emergency, AHCCCS is temporarily redirecting staff efforts. As a result, the delivery of this report for the March through June time periods was delayed until August. The agency is now submitting the reports for March through June to comply with the requirement above. On July 31, 2020 the agency separately submitted the report for July to comply with the requirement.

AHCCCS implemented methodological changes in developing the March through July reports that resulted in slight adjustments from previously reported counts of members served and enrolled. The agency will use this revised methodology for future reports and has restated previous reports with counts made under the new methodology back to July 2016.
