Dear President Biggs and Speaker Gowan:

A.R.S. § 41-3955.01, subsection D, requires AHCCCS to submit a report on the status the Seriously Mentally Ill (SMI) Housing Trust Fund, including a summary of facilities, the cost and location of each facility, and the number of individuals benefiting from operation, construction or renovation of the facilities.

In total, 152 individuals were served by the \$1,764,083.05 in SMI Housing Trust Fund monies spent in FY 2016. Table 1 below displays the location of each facility and the associated expenditures by location:

In addition to these monies, an additional \$1,903,684.78 million in FY 2016 funding has been allocated for expenditure in FY 2017, for a total of \$3.667,767.83 spent over the two years. These funds have been allocated as follows:<sup>2</sup>
